## Update - Augsburger Road Pathway Project

Jamie reported that right-of-way paperwork for two property owners is still out, waiting for approval from their Boards. Both are in process. The culvert on Augsburger Rd. has been replaced with allowance made for the bike path. Paving should take place this week. Still waiting for the permit from Fish and Wildlife. The wetlands have been delineated. Tree removal to take place between October and March after the permit is received. ODOT is still working with a 2016 schedule.

# Review of Meeting with Bluffton Village Alleys & Streets Commission

Joe Sehlhorst stated that the village is still eager to see where the true ROW for Bentley Road is. Jamie reported that he has been in contact with Leland Yoakam Survey. His company established the boundaries of BU about 5 years ago, which will be a starting point for determining the actual ROW for Bentley Rd. Jamie hopes for an estimate soon. It was decided that the Village should contact the home owners on Bentley Rd. to alert them to the fact a survey is to be done citing the village's review of Bentley Road from a safety perspective as the motivation.

# **Bridges**

Conversations have been had with Brion Rhodes, County Engineer regarding plans for the Bentley Rd. and Columbus Grove-Bluffton Rd. bridges. Both bridges will need to be replaced in the coming years, perhaps 2022. Funding is difficult to get and bridges must be prioritized for replacement. The county engineer is applying for grants to help with bridge replacement in the county. Dick noted that our organizations (Lions Foundation, Pathway Board, etc.) should submit letters of support to the County Engineer outlining the vision for the bike path and how the bridge replacements impact the pathway plans. It will also be helpful if the Village/Pathway Board is able to include plans for development of the pathway up to each bridge. Such plans will help the county engineer make decisions about type and design of the replacement bridges.

Dick shared that further discussion with the village and county engineer led to the conclusion that it will be most economical and the best plan to keep the pathway on top of the bridge, rather than trying to go under.

# The Pathway and Motter Park

Bob Antibus was present as a representative of the Johnny Appleseed Parks. Bob shared thoughts on the future plans for Motter Park. Shared a common problem with bike paths that are located in flood plains—flooding and wash-away is always a concern which increases maintenance and makes the path inaccessible at times. It was noted that the Parks may have access to some funds not available to the village or the Pathway Board—discussed ways to collaborate. It was suggested that it would be helpful if the Bluffton Pathway Board attended a Johnny Appleseed Parks Board meeting regarding our vision after we know more about our plan for Bentley Rd.

# **General Discussion**

Final cost of the Lions Way Path and the Augsburger Rd. pathways were reviewed (private funds vs ODOT funds). All agreed that if we could avoid using ODOT funds for Bentley Rd. it would be best. Could it possibly be funded by a combination of tax dollars and private funds, i.e. a public-private venture? Are there ways to lower the cost? It was suggested that 8 ft. wide would be adequate, rather than the 10 ft. required by ODOT. The narrower path would also be helpful as we try to gain ROW along Bentley.

Village of Bluffton Pool Questionnaire - 2015

During the 2015 pool season, the Village of Bluffton, with the help of our Bluffton University intern, conducted a customer satisfaction survey to see how well our Village pool is meeting our customers' needs. Thirty-one customers filled out and returned the questionnaire to the pool manager. Since the questions were open-ended, many of the respondents provided more than one answer per question.

  - ii. Objective #2: Develop a long term acquisition plan that will ensure for future needs and growth of the Bluffton park system.

#### 2. User Survey

 Results fairly definite in their agreement: cleanliness, improved restrooms, safety, playground equipment, picnicking and shelters, and continued development of the walkways and trails were most pressing needs.

# 3. Park Development Plans

Information from Survey not intended to identify, design, and prioritize every item to be completed at that site in the future. It is meant to identify the physical characteristics of the Park, as well as limitations at the site. VP

- a. Park Development Plans
  - i. Village Park Plan
    - 1. Recreation area: Soccer, Baseball, Softball, and Physical Activities
    - 2. Opportunities identified: buildings, water system, drinking fountains, nature trails, wildlife and nature plantings, playground equipment, fitness trails, exercise stops, benches and rest areas, improved signage, more shelter facilities, upgraded utilities such as lighting and electric, and improved safety.
      - a. Develop landscaping plan with a consistent theme. Landscape design to create a more pleasing and inviting entrance.

## ii. Buckeye Park Plan

- 1. Passive area: Picnicking, Fishing, Children's Playground, Basketball, and general passive activity such as Reading and Walking.
- 2. Opportunities: upgrade playground facilities; install lighting system for added safety and security, later evening use of park for walking, etc.
- 3. Bluffton Village Pool
- 4. Pathway System
  - a. 2015, Pathway Board identifying options, West Side Interceptor Project

## 4. Priorities

a. Survey results show the public want clean parks, want the parks to be safe, and they want to be able to find picnicking facilities when they go to the parks. The community is involved in walking, biking, and hiking activities and wants to have better support facilities, such as restrooms, water, and lighting as they use the parks.

## 5. Funding

- a. When financial considerations are discussed, a Park System is often viewed as expendable or not a pressing need. However, park/community supporters are firm in the belief that the long term health of a community is often measured by the attention paid to its quality of life.
  - i. Benefits of expenditures hard to measure in dollars.
    - 1. Can repay them by creating feeling of community, positive attitude of community members and volunteers.
    - 2. Strengthens our neighborhoods, and keeps the Village a good place for people to live, and businesses to locate and prosper.

#### Space

The Bluffton public sector supports and values the investment in the maintenance and set aside of dedicated space to support the activities of a healthy lifestyle. For example the bike path, parks, public sidewalks, and various green spaces that encourage the public and private sector collaboration to assure affordable access to such space and facilities will be protected and enhanced through such collaboration.

#### **Health Districts**

The Village of Bluffton supports the healthcare providers in the establishment and development of "fitness, health or healthcare zones" to focus land utilization without impinging on others and to allow for growth and economically functional areas within the Village. (not so different than restricting the use of the "Bike Path" to bicyclist and walkers and coordination with zoning efforts, and other land development)

## I-75 Think Overpasses and/or Village Park running along I-75

We should invest as a community in professional design consultations regarding how to make Bluffton have a welcoming appearance and a well designed appearance to persons as they enter town from Interstate 75. This should be a high priority. Each month of delay makes the task that much more difficult as development occurs without coherence and coordination.

#### **Events in the Parks**

Promotion of local ethnic festivals. (For example, DTR and Japan, Grob and Germany, and expansion of Swiss Day.)

## The long-term big picture

In the event of the abandonment of the Norfolk and Southern Railroad through town we should act quickly to assure the right of way becomes a bike-walking path. It could extend from Findlay to Lima or further. We missed our chance when the AC&Y was abandoned in the 1980s.

Consideration should be given to by the village to purchase land along Riley Creek for long-term park expansion.

We would encourage the village to create an outdoor art commission made up of art professionals. Its task: explore commissioning of larger sculptures downtown and through the village. A small, first step would be the re-creation of the "Riley Creek" drinking fountain in front of the bank. Imagine a Bluffton in the next 25 years with 10 to 15 outdoor sculptures scattered across our landscape.

# **Green Spaces**

For purposes of this report, the Bluffton University Nature Preserve is considered green space and must be protected and maintained to protect its environment and wildlife. It is recommended that plans be established to protect the flood plains and stream beds that

flow through the village. The Little Riley and Riley Creeks provide the perfect opportunity for a system of green spaces which could be connected by a series of walking paths. Public acquisition of this area should be encouraged or incentives offered to current property owners to promote the dedication of natural areas.
