Hello All,

What a world in which we live! No one knows when life will get back to "normal." Or what that normal will look like. It is tough when your main job in life is planning activities for senior citizens to socialize and no one is allowed to socialize or knows how long all this will last. Thank you all for doing your part and staying safe at home. Please know that the staff is thinking about you and praying for you.

I can share what little I know for sure and what I think might happen. This newsletter will be unlike any I have written in the past and I hope and pray, unlike any I will ever have to write in the future. So, let's start with what I know. Governor Mike DeWine has a press conference almost every day at 2 p.m. I do not recommend watching everyday unless you are a news junkie. It can get overwhelming for some of us. The broadcast can be found on NBC out of Lima or PBS out of Bowling Green. Governor DeWine is always asked when things will begin to open up. He has said that even when the restrictions begin to lessen, large groups will still be off limits. To that end, I have cancelled the Dinner Meetings for May and June and the Community Meals for May and June as they are the biggest crowds that we get. Let's start with what I think it will look like when the restrictions begin to lessen, knowing that the Governor may tell us differently.

Phase one; The staff will come back to work in the Senior Center and members will be allowed in to borrow items from the library, use the exercise equipment and talk with staff.

Phase two; Small groups will be allowed to meet such as cards, dominos, crafts, music Jam session and eventually we will restart exercise class.

Phase three; Dinner Meetings, Community Meals, dances, Bingo, extra classes and special activities like movies will resume.

Phase four; Party Time! When we are in the clear, whenever that may be, I plan to throw a nice big party.

I believe we will still need to take precautions like hand sanitizer and even masks. I am trying to prepare for those possibilities. You may have noticed that trips were not listed yet. Trips have to be evaluated on a case by case basis. Please keep an eye on the trip pages to see which trips are cancelled, postponed or pending.

So, the big question; how will you know when this is going to happen? I think you are just going to have to watch and listen to when the Governor starts to lessen the restrictions and then call us to see if we are open. The rest of this newsletter is filled with information to help you get through these hard times and look toward the future. Stay safe everyone and try to find a little joy in the slower pace of life.

PHONE CALLS

Some of you have been called by one of the staff of the Bluffton Senior Center. We have been trying to call every member of the Senior Center to check on the wellbeing and to see if there is anything we can do. If you haven't received a phone call, it is probably because of one of three reasons. 1. We have the wrong number for you or no number for you. 2. We haven't gotten to you yet but we will. 3. We called but you didn't recognize the home phone number of the employee so you didn't answer. If there is something that we can do for you at this time, please don't hesitate to call or email. SCAMS

Some people are trying to take advantage of the virus and stay at home order. One of the scams that I have seen already is a large check that says it is a government relief check. As far as I know, the stimulus checks have not gone out yet and the government will use direct deposit whenever possible. If you get your Social Security Check directly deposited, that is the most likely way you will get any stimulus money. If you try to deposit a scam check, they will most likely try to empty your bank account.

As of the writing of this newsletter, there are no remedies or vaccines or drugs that can protect your from COVID 19. Anyone trying to sell you one is a scammer and out for your money. Testing for the virus can only be ordered by a doctor. You cannot buy one. Anyone who says differently is a scammer. Other claim to be selling masks, cleaners and other supplies. Ask yourself why they are contacting you. Don't buy from anyone you don't know.

AARP also warns of investment scams. People are promoting companies with products that supposedly can prevent, detect or cure COVID 19 and are set to soar in price. Be sure to check with your broker before falling for this scam.

Be aware that emails and websites that have "coronavirus" or "covid" in the domain name are most likely to be malicious. They might plant malware on your computer to get your personal information or set you up for more scam emails. Be careful of what you click on.

There are also reports of individuals going door to door offering to get groceries or other supplies. If you don't know them or asked someone for help, I would not trust them. Please do not give them money or a credit card. It is safer to ask someone you know for help.

These are the few of the scams that I have heard of. If you feel you have been scammed, see the phone numbers on page two to report it. It is important to report scams so they can be tracked and others can be warned.




