Dear Soccer Parent:

Soccer Registration for the spring is here again! Enclosed are the registration forms for your child and an Evaluation and Feedback form. Please review and make any necessary changes to the registration form and sign the Black Swamp Soccer Liability Consent form. Please return forms to Bluffton Soccer along with your payment in person or by mail prior to **February 12, 2011**. We will be having open registration at the Bluffton Middle School from 5 to 8 pm on Jan 26, Feb 2 and the 9th or you can mail the forms to Attn Ron Koontz. 7960 Rockport Rd Bluffton Ohio 45817. We do have a new web address where everything can be downloaded. www.BlufftonSoccer.com. **DO NOT GIVE/SEND REGISTRATIONS TO BFR. We will not get them and your child will not be registered.**

The cost this season (like Fall '10) will be \$45 for ALL players. **PLEASE MAKE YOUR CHECK OUT TO: BLUFFTON SOCCER CLUB.** A family's first child is charged the full price with a \$5 reduction for a second child and a \$10 reduction for any subsequent children (up to 3). ***(This does not include U6 Soccer or indoor participation!)*** However, a late registration fee of \$25.00 **will be** assessed after **February 12, 2011** and this does not guarantee your child will be placed on a team. If your child does not get placed on a team your money will be refunded. The league assesses late fees for all players and teams added after the deadline. We encourage you to attend one of the three registration days so we can make sure all paperwork is filled out correctly. If your child has not played in the past, we will need a copy of your child's **BIRTH CERTIFICATE**. **If we do not have the BIRTH CERTIFICATE and monies your child can not play. (New registrations only)**

When completing the registration form, please note any special requests (i.e. car pooling issues) in the box marked Requests/Comments. We will **try** to honor as many as possible, **we cannot guarantee all requests will be fulfilled**. Please keep in mind that with smaller team sizes, it becomes more difficult to honor these requests.

We also ask that you indicate in the Requests / Comments box whether your child is participating in any other sports or activities that may interfere with soccer practices or games. If you are unsure whether the activity will interfere with soccer, please err on the side of caution and list the activity. **We also need your child's Jersey size so we know ahead of time what size to give to the coach. The coaches will hand out all your uniforms this year.**

IMPORTANT NOTE FOR ALL GIRLS: If possible all girls will be put on a girl's team. Our ability to field All-Girls teams is based on the number of players in each age group, and the availability of coaches. If there is not enough girls they will be on a co-ed team. Our club has fallen behind other community clubs in numbers of All-Girls teams and attempts will be made to encourage more girls' teams at the U8, U10, U12 and U15 level. In the event we cannot place all the girls on an all-girl team, a lottery system and player evaluation from the Bluffton Soccer will be used to assign all teams. This change is due to the Black Swamp and OYSAN suggestions.

Practices are expected to start the first of March with BSSL league play from March. 20 – May 22. Games will be starting April 2th thru May 7th. All are reminded that two tournaments are available in the spring for our league participants; May 21 & 22 at Bluffton for U12 and U15 teams, and May 14 & 15 at Riverdale for U8 and U10 teams. Our teams ***are expected but not required*** to participate in these tournaments but ***entry cost is up to the team***. We will be needing help this year with hosting the Bluffton tournament. So if you can help, please let us know.

The current Bluffton Soccer Committee is mostly comprised of volunteer coaches, but we would like to involve more parents or others interested in soccer on the committee. If you are interested in becoming more involved in Bluffton Soccer, please indicate your interest on the registration form and we will contact you with additional information.
